









Fig.2< Terminal temperature>

For resistors operated at the ambient temperature in excess 70°C or terminal temperature* in excess the rated terminal temperature, load shall be derated in accordance with Fig.1 and Fig.2.

■ LTR18




Fig.3< Terminal temperature>

For resistors operated at the ambient temperature in excess 70°C or terminal temperature* in excess the rated terminal temperature, load shall be derated in accordance with Fig.1 and Fig.3.

■ LTR50

For resistors operated at the ambient temperature in excess 70°C or terminal temperature* in excess the rated terminal temperature, load shall be derated in accordance with Fig.1 and Fig.4.

■ LTR100





Fig.5< Terminal temperature>

For resistors operated at the ambient temperature in excess 70°C or terminal temperature* in excess the rated terminal temperature, load shall be derated in accordance with Fig.1 and Fig.5

■ Jumper type

For resistors operated at the ambient temperature in excess 70°C, the load shall be derated in accordance with Fig.1.
