






Fig. 7.1 Marking





Fig. 8.6 V_{CE(sat)} - T_c






Fig. 8.13 C - V_{CE}




Fig. 8.15 IF - VF




Fig. 8.17 Safe Operating Area (Guaranteed Maximum)




Fig. 8.14 V_{CE}, V_{GE} - Q_g




Fig. 8.16 I_{rr},t_{rr} - I_F





Fig. 8.18 Reverse Bias SOA (Guaranteed Maximum)




