You may not (i) distribute, sublicense or copy any portion of the Product; (ii) modify or prepare derivative works from the Product; (iii) use the Product in a computer based service business or publicly display visual output of the Product; (iv) transmit the Product electronically by any means; (v) use the Product in multiple computer or multiple user arrangements unless that use is covered by individual license for each computer or use; or (vi) reverse assemble or reverse compile the Product. derivative works from the Product; (iii) use the Product in a computer based service business or publicly display visual output of the Product; (iv) transmit the Product electronically by any means; (v) use the Product by more than ten users unless that use is covered by individual license for each computer or use; or (vi) reverse assemble or reverse compile the Product. ### 3. LIMITED SOFTWARE WARRANTY.

Hearst warrants, for thirty (30) days from delivery to you, that the CD-ROM disk on which the Product is contained will be free from defects in materials and workmanship. ### 4. DISCLAIMER OF WARRANTY AND LIMITATION OF LIABILITIES.

### 5. LIMITATION OF REMEDIES.
